Dear Ms. Duggan and Members of the OC Development Services Review Committee,

As a resident of Corona Del Mar who walks by the proposed site multiple times each week, I am deeply concerned about the impact this project would have on the neighborhood. The proposed facility would replace a natural green space with cell towers and support equipment, introducing the hum of power systems and generators in place of the peaceful sounds of birds and other wildlife. This would permanently alter the character and livability of the area.

This location currently serves as a peaceful, family-friendly environment where children play, neighbors walk, and residents enjoy the natural surroundings. Replacing this space with industrial equipment risks making the park and nearby walking paths less desirable and incompatible with their intended community and recreational purpose.

I respectfully request that OC Development Services require full documentation and evidence before any approval of the proposed wireless facility. This should include, at a minimum, the following items:

Site Development Plans and Drawings:

Complete plans, elevations, concealment designs, and landscaping showing neighborhood impact.

Technical Documentation:

RF coverage maps, engineering reports, and propagation analyses supporting the proposed location.

Environmental Review:

Applicable CEQA documentation or equivalent environmental review.

Alternatives Analysis:

Evaluation of feasible alternate locations, co-location options, or lower-height solutions. The proposed location is only appropriate if it is the last resort.

Relocation Suggestion

Analysis of moving the facility further into the golf course where natural elevation and vegetation reduce impacts and distance it from homes.
