ITEM #2 USE PERMIT PA23-0119 - APPLICANT: CALIFORNIA QUARTET, L.P., AGENT – MICHAEL RECUPERO – LOCATION: EASTERN SIDE OF EL TORO ROAD, APPROXIMATELY ONE-HALF MILE SOUTH OF THE INTERSECTION OF SANTIAGO CANYON ROAD (EL TORO ROAD) AND LIVE OAK CANYON ROAD, IN UNINCORPORATED ORANGE COUNTY WITHIN THE THIRD SUPERVISORIAL DISTRICT.

The applicant is requesting a Use Permit to establish residential development standards for the Saddleback Meadows development through a Planned Development combining district to facilitate development of the approved 181-unit development.

RECOMMENDED ACTIONS:

OC Development Services/Planning recommends the Planning Commission:

1. Receive staff report and public testimony.
2. Adopt Planning Commission Resolution No. 26-01 to:
 - a. Find that the project is considered in RSEIR No. 566, certified by the Board on November 5, 2002, RSEIR No. 566 Addendum No. 1, administratively approved on August 11, 2004, and RSEIR No. 566 Addendum No. 2, administratively approved on September 26, 2022, which adequately addressed the effects of the proposed project; and
 - b. Approve Planning Application PA23-0119 for a Use Permit to establish residential development standards for Saddleback Meadows development through a Planned Development combining district subject to the Findings and Conditions of Approval contained within the Resolution.
